**DECLARATION OF SANDY LINTER**

I, SANDY LINTER, declare as follows;

1. I have personal knowledge of the facts set forth herein and if called as a witness, I could and would competently testify thereto.

2. I am a makeup artist. I have known Janice Dickinson since the mid-1970s and the early days of her modeling career.

3. While I worked on Ms. Dickinson in the early 1980s, Ms. Dickinson told me that Bill Cosby, the entertainer, had attacked her.

4. Recently, when this story appeared in the New York Post, I became very upset so I called Edward Tricomi, a world renowned hairdresser and a good friend of mine and Ms. Dickinson. I told him the story while I cried, and he told me that Ms. Dickinson had told him the same story about Mr. Cosby attacking her.

5. Ms. Dickinson was very serious and focused when she told me about Mr. Cosby's attack. I have never known Ms. Dickinson to lie. I found her to be very credible.

6. I was stunned by Ms. Dickinson's story for a long time. I did not reunite with Ms. Dickinson for many years. The next time I thought about what had happened between Ms. Dickinson and Mr. Cosby was in the 1990s when the story about Autumn Jackson (the young woman claiming to be Mr. Cosby's illegitimate daughter) came out. I remember thinking to myself that Autumn Jackson is telling the truth because Janice had told me about Mr. Cosby's behavior many years ago.


7. I always thought of Ms. Dickinson as a trusting and honest person.

8. Ms. Dickinson has a reputation in the community for truthfulness.
